Employment Training Panel Approves More Than \$8.3 Million To Train Nearly 7500 Workers

DOME Printing in Sacramento to Train 240 Employees

SACRAMENTO – The State of California's Employment Training Panel announced the approval of 23 contracts worth more than \$8.3 million to train 7,472 workers. One of the contracts approved by the Panel includes \$339,000 to train 240 employees – including five veterans and 25 new hires – at Sacramento-based DOME Printing.

"These training contracts are significant economic development tools for businesses and their employees," said Stewart Knox, the Employment Training Panel's Executive Director. "Workers receive job training for well-paying jobs, and businesses can grow their workforce and revenue."

Meriliz Incorporated, doing business as DOME Printing (DOME), was founded in 1914 as a small engraving company serving local printers and newspapers. In 1969, the company incorporated and has grown into a large commercial printing company. Recently, DOME has expanded its business to include creative services, digital printing, mailing, e-mail marketing, fulfillment and distribution, and support services.

"ETP has benefited DOME during our expansion in to national markets by helping us provide high quality training," said Bob Poole, Chief Marketing Officer and Owner of DOME Printing. "Our employees are receiving training to maintain and improve our world-class business, from operations and maintenance to leadership. Through these trainings, employees will have a greater opportunity for advancement."

Under the proposal approved today, DOME Printing will train more than 240 workers at its Sacramento and Richmond locations, including approximately 25 new hires, and five veterans. Training will be provided to new and current administrative staff, sales representatives, production staff, programmers and managers. The training will focus on streamlining current processes and procedures to improve overall production efficiencies and quality.

The Employment Training Panel is the state's premier program supporting job creation and retention through training. The panel reimburses employers for the costs of training existing workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
