**Employment Training Panel Approves Over \$11.8 Million
in Job Training Funds for Over 12,500 Workers**
Duarte Nursery Inc. Receives Contract to Train 400 Employees

SACRAMENTO – The State of California’s Employment Training Panel today approved 70 contracts worth over \$11.8 million to train over 12,500 workers. One of the contracts approved by the Panel includes \$333,000 to train 400 employees at Duarte Nursery Inc.

“Family owned and operated businesses play an important role in California’s economy,” said Stewart Knox, the Employment Training Panel’s Executive Director. “The training projects approved today help companies like Duarte Nursery meet their need for skilled workers, stay competitive within their industries, and offer enhanced job opportunities for their employees.”

Founded in 1988 and located in Hughson, California, Duarte Nursery is a family-owned and operated commercial grower that produces avocado, almond, cherry, pistachio, citrus, and walnut trees, grapevines, and poinsettias. Duarte Nursery is the largest permanent crops nursery in the United States, and sells its products to local farmers, commercial growers, nursery retail stores, and home growers.

Duarte Nursery also owns Dry Creek Laboratories, an on-site laboratory for research on plant improvement and variety development for the nursery. The laboratory’s focuses include rapid vine establishment and fruit production, variations in growing conditions, evaluation of clones, and the propagation of rootstock. Duarte specializes in fully containerized growing, which limits each plant’s exposure to toxins and parasites, and allows all plants to be available for delivery at any time of year.

“Our participation with ETP couldn’t come at a better time. Our company is growing fast and we owe it to our employees to give them the best chance to succeed in the workplace,” said Jeff Duarte, Operations Manager at Duarte Nursery. “ETP is allowing us to provide training resources that make that happen. We can’t wait to get started.”

Over the past three years, Duarte Nursery has grown by 15 percent, which the company attributes to increased demand from the international exporting of its products. The training provided through the contract approved today will help Duarte Nursery meet this increased demand while improving efficiency, inventory and shipping processes, increasing customer satisfaction, and reducing waste. Under the proposal approved today, Duarte will train 300 incumbent workers and 100 seasonal workers at their single facility located within a designated High Unemployment Area.

The Employment Training Panel is the state’s premier program supporting job creation and retention through training. Since its creation in 1982, the panel reimburses employers for the costs of training existing workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
