Employment Training Panel Approves \$4.9 Million To Train Nearly 5,000 Workers

Includes \$1.1 Million for Two Apprenticeship Proposals to Train 516 Workers

SACRAMENTO – The State of California’s Employment Training Panel today awarded 15 contracts worth more than \$4.9 million to train nearly 5,000 workers. The panel awarded \$1.1 million in apprenticeship training funds to the Orange County Electrical Joint Apprenticeship and Training Trust Fund and San Mateo County Electrical Joint Apprenticeship and Training Committee to help to train 516 apprentices, including 45 veterans.

“The Employment Training Panel is pleased to award training contracts for apprenticeship proposals in established programs that help workers grow their skills to meet employers’ needs,” said Employment Training Panel executive director Stewart Knox. “The two apprenticeship proposals approved today offer job training that can increase career opportunities for workers, including returning veterans.”

Both electrical apprenticeship programs funded today work in cooperation with [Helmets to Hardhats](#), a national joint labor-management program that connects retired and transitioning active-duty military service members with training and career opportunities in the construction trades.

The Orange County Electrical Joint Apprenticeship and Training Trust Fund is administered by the Orange County Chapter of the National Electrical Contractors Association and the International Brotherhood of Electrical Workers Local 441.

“We recognize that veterans have already acquired significant skills while in service,” said Orange County Electrical Joint Apprenticeship and Training Trust Fund training director Dave Lawhorn. “Veterans who apply for the apprenticeship program skip the first stage of approval, a written assessment, and qualify immediately for an oral interview.”

The San Mateo County Electrical Joint Apprenticeship and Training Committee is governed by a Board of Trustees comprised of four labor and four management representatives, and is a joint effort of the International Brotherhood of Electrical Workers Local 617 and the National Electrical Contractors Association.

“ETP continues to play a critical part in allowing us to make our apprenticeship program available to returning veterans and support our community,” said San Mateo County Electrical Joint Apprenticeship and Training Committee training director Kathleen Barber.

The Employment Training Panel is the state’s premier program supporting job creation and retention through training. The panel reimburses employers for the costs of training existing workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
