Employment Training Panel Approves \$20.4 Million to Train 20,700 Workers

El Camino College Awarded \$533,450 to Train 470 Workers in Clean Vehicle Technologies

SACRAMENTO – The State of California's Employment Training Panel today awarded 86 contracts totaling \$20.4 million to train 20,700 workers. One of the contracts approved by the panel includes \$533,450 in funding from the California Energy Commission to train 470 workers in alternative fuel and vehicle technologies at El Camino College in the city of Hawthorne.

"The transportation sector's transition to cleaner fuels and technologies will require well-trained workers," said Stewart Knox, the Employment Training Panel's executive director. "We are pleased to support job training contracts in clean technology industries that move California's economy toward meeting its ambitious climate goals."

El Camino College's contract will be funded through the Energy Commission's <u>Alternative and Renewable Fuel and Vehicle Technology Program</u>, which provides up to \$100 million a year to support innovations in transportation and fuel technologies that help California meet its energy, clean air, and climate change goals. The Energy Commission partners with the Employment Training Panel to fund job training programs that support the transition from petroleum-based transportation to alternative and renewable fuels and cleaner, less-polluting vehicle technologies.

"The Energy Commission is committed to investing in projects that support the state's efforts to reduce its greenhouse gas emissions and create pathways to clean-transportation jobs in California that pay a living wage," said Janea A. Scott, Commissioner at the Energy Commission. "We look forward to continuing work with partners to meet the growing demand for a well-trained workforce in the clean transportation sector."

Under the proposal approved today, El Camino College and its training providers will train 470 workers in job skills needed to produce and distribute new alternative fuels, and to design, construct, install, operate, service and maintain new fueling infrastructure and vehicles.

"This alternative fuel and vehicle funding contract allows El Camino College and its training partners to offer education, training and resources to increase employees' job skills in advanced transportation and clean technologies," said Eldon Davidson, director of the Center for Customized Training at El Camino College.

The Employment Training Panel is the state's premier program supporting job creation and retention through training. The panel reimburses employers for the costs of training existing workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
