**Employment Training Panel Approves More Than \$8.6 Million
To Train Nearly 11,900 Workers**

Four Healthcare Proposals Approved to Train 126 New Hires

SACRAMENTO – The State of California’s Employment Training Panel awarded 28 contracts worth more than \$8.6 million to train 11,836 workers. Four of the contracts support job creation in the healthcare industry, with Temecula Valley Hospital, San Gabriel Valley Medical Center, Pacific Alliance Medical Center, and Whittier Hospital Medical Center planning to train a total of 126 new hires.

“Our new hire incentive program helps new nurses get the on-the-job training skills they need while supporting the growth of California’s healthcare sector,” said Stewart Knox, the Employment Training Panel’s Executive Director. “Employers that pay the Employment Training Tax can apply for training contracts to help their workers grow their skills and their businesses.”

Temecula Valley Hospital is the first hospital built in the City of Temecula. The hospital has 140 private licensed beds, 20 extensive care beds, four high-tech surgical suites, a cardiovascular surgical suite and a catheterization laboratory. It plans to open a new progressive care unit in fall 2016, and is planning on adding two cardiac catheterization laboratories and another operating room suite. Temecula Valley Hospital will use its training contract to hire 35 registered nurses to increase patient demands from its planned expansion.

“We are very pleased to participate in this program to further enhance our nurse training programs to meet the needs of our growing hospital and the community we serve,” said Amber Gollogly, representative for Temecula Valley Hospital.

Pacific Alliance Medical Center in Los Angeles is a fully licensed and accredited acute care, general medical and surgical facility. The medical center maintains a 24-hour urgent care unit and provides numerous surgical services. With its increases in patient care demand, the medical center will use a portion of its approved funds for training 30 new employees on advanced and critical care skills. The additional new employees will allow Pacific Alliance Medical Center to maintain adequate staffing ratios and support expanded hospital service.

San Gabriel Valley Medical Center is a full-service acute care hospital with 273 licensed beds. With a shortage of experienced nurses in the community and greater service area, San Gabriel Valley Medical Center has committed to hiring and training 16 new graduate registered nurses to maintain adequate staffing ratios and increase the hospital’s capacity to meet growing patient care requirements.

Whittier Hospital Medical Center is a full service acute care facility with 178 licensed beds. Whittier Hospital has committed to hiring 45 new employees including 30 registered nurses. These employees are needed to maintain adequate staffing ratios and to support the hospital’s expanding patient care in its emergency, perinatal and perioperative departments and programs.

The Employment Training Panel is the state's premier program supporting job creation and retention through training. The panel reimburses employers for the costs of training existing workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
