Employment Training Panel Approves Over \$9.8 Million in Job Training Funds for Close to 12,000 Workers

Karma Automotive Receives Contract to Train More Than 400 Employees

SACRAMENTO – The State of California's Employment Training Panel today approved 59 contracts worth over \$9.8 million to train close to 12,000 workers. One of the approved contracts is for \$830,000 to train more than 400 current and newly-hired employees in the production of plug-in electric hybrid vehicles at Karma Automotive, LLC.

"The Employment Training Panel is pleased to support new, innovative manufacturers by helping them meet their needs for skilled workers," said Stewart Knox, the Employment Training Panel's Executive Director. "The job training contracts approved today address job creation and retention while increasing opportunities for workers through the development of job skills and training."

Founded in California, Karma Automotive – formerly known as Fisker Automotive and Technology Group, LLC. – will be re-starting their production of plug-in electric hybrid vehicles. Based on Karma's planned expansion and commitment to adding new jobs in California, the Governor's Office of Business and Economic Development has designated this project as a Critical Proposal.

"GO-Biz is proud to count Karma Automotive among the growing number of car companies choosing to locate and manufacture in California," said GO-Biz Director, Panorea Avdis "The Employment Training Panel is one of the State's critical economic development tools which GO-Biz utilizes to incentivize new job creation."

Karma Automotive recently opened a new headquarters in Costa Mesa, and is opening a third California location in Moreno Valley, where it will hire close to 170 new employees for its manufacturing activities.

Karma's new hybrid vehicles will contain 40 microcomputers and a new and more efficient nanotechnology battery. The company will imbed solar panels in the roofs of their vehicles, and will also install rooftop solar panels on its manufacturing center in Moreno Valley to demonstrate its commitment to green clean and advanced technologies.

Under the proposal approved today, Karma Automotive will train more than 400 workers, including approximately 250 incumbent workers, some of whom are veterans or individuals with disabilities. Karma will also train approximately 170 newly hired employees. The employees will learn skills in manufacturing, computers, advanced technology and hazardous materials.

The Employment Training Panel is the state's premier program supporting job creation and retention through training. Since its creation in 1982, the panel reimburses employers for the costs of training existing workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
