Employment Training Panel Approves More Than \$13.7 Million To Train Nearly 14,600 Workers

Two Community College Districts Awarded More Than \$1 Million

SACRAMENTO – The State of California’s Employment Training Panel awarded 35 contracts worth \$13,799,251 million to train 14,541 workers. The panel awarded two contracts worth more than \$1 million combined to the San Bernardino Community College District and Ventura County Community College District to train more than 1,900 workers in manufacturing, crop production, transportation and distribution industries.

“The Employment Training Panel makes a difference for employers and workers throughout California by investing in a highly-skilled and well-trained workforce,” said Stewart Knox, the Employment Training Panel’s Executive Director. “Our partnerships with community colleges help to connect employers with quality job training, which is especially important for small to medium-sized employers with human resource budget constraints. These employers are able to leverage training funds and the community college expertise to increase their workers’ skills to their competitive advantage.”

The panel awarded San Bernardino Community College District \$950,000 for training by its Economic Development & Corporate Training division to train 1,888 workers. The division provides training to large and small businesses in the manufacturing, distribution, and transportation industries, and the training dollars will be focused on productivity and production quality in the manufacturing process, computer skills and computer literacy, customer service skills, and written and verbal communication skills.

“I would like to thank the Employment Training Panel for their ongoing support for the businesses located within the Inland Empire,” said Robert Levesque, Director of Workforce Development, San Bernardino Community College District. “We are eager to begin training and with the approval of the new contract, an additional 2,000 workers will have the opportunity to receive training to upgrade their skillsets.”

Ventura County Community College District received an \$88,750 contract to train 35 workers to focus on equipment operation and production skills, workplace communication, software applications, database management and report generation.

“Ventura County Community College District has been providing workforce training to businesses within Ventura County for many years,” said Rick Post, Vice Chancellor of Educational Services. “By becoming an ETP training provider, our district’s office of Economic and Workforce Development will be able to expand its contract training services to new and existing businesses that would otherwise be unable to afford customized worker training.”

The Employment Training Panel's training contracts with community colleges encourage advanced and relevant training for industry-linked programs. By increasing their skills, training participants increase their value to key industries.

The Employment Training Panel is the state's premier program supporting job creation and retention through training. The panel reimburses employers for the costs of training existing workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
