**Employment Training Panel Approves \$10.8 Million
to Train 12,086 Workers**

Nearly \$300,000 Awarded to Train 280 Trade Show Apprentices

SACRAMENTO – The State of California’s Employment Training Panel announced today it approved 42 contracts worth \$10.8 million to train 12,086 workers. The panel awarded nearly \$300,000 to the California Tradeshow and Sign Crafts Joint Apprentices Training Trust Fund to train 280 apprentices in the building and installing of exhibits at conferences, conventions and trade shows.

“The Employment Training Panel supports apprenticeship programs that help workers grow their skills to meet the demands of growing industries,” said Employment Training Panel executive director Stewart Knox. “Apprentices in trade shows have nearly tripled since 2014, and the training funds awarded today will help apprentices acquire skills that lead to middle-class careers and enhance opportunities to promote in the industry.”

The California Tradeshow and Sign Crafts Joint Apprentices Training Trust Fund serves trade show workers of Tradeshow and Sign Crafts Local Union 831 in Southern California and Sign Display and Allied Crafts Local Union 510 in Northern California. The workers are employed by companies that build and install exhibits at trade shows, major convention centers, hotels, and other conference and exhibit venues. The joint program had 111 active apprentices in 2014 compared to the approximately 300 apprentices today, which the program attributes to an increase in trade show business and the need for skilled workers.

“This funding will help us train more people to work safely and quickly to build, install and tear down exhibits at conventions and trade shows,” said Fred Wright, the coordinator for the California Tradeshow and Sign Crafts Joint Apprentices Training Trust Fund.

The approved apprenticeship training supported by the panel funding includes an introduction to the trade show industry, safety, rigging, layout, installation, graphics, dismantling of exhibits, math, schematics and drawings, and how to build custom booths.

The Employment Training Panel is the state’s premier program supporting job creation and retention through training. The panel reimburses employers for the costs of training existing workers, funds training for unemployed workers to re-enter the workforce and helps to ensure California businesses have the skilled workers they need to remain competitive.
