Employment Training Panel Awards \$15 million to Train 10,800 Workers *Reborn Cabinets awarded \$524,400 to expand workforce opportunities for Californians*

SACRAMENTO – The State of California's Employment Training Panel announced that it approved 59 contracts worth nearly \$15 million to train 10,800 workers. The panel approved \$524,400 in training funds for Reborn Cabinets to help hire and train 285 workers in the manufacturing industry.

"This training contract will help Reborn Cabinets advance the skills of their employees," said Reg Javier, Employment Training Panel Executive Director. "We are always pleased to support projects that offer job training opportunities for workers."

Reborn Cabinets is a family-owned business that designs, manufactures, and installs custom cabinetry in kitchens and baths for homeowners. With the expansion of its establishment, the Governor's Office of Business and Economic Development has designated this project a Critical Proposal as Reborn Cabinets will be providing new jobs for 285 new employees.

In April 2020, Reborn Cabinets initially faced some challenges due to the COVID-19 pandemic, which led to some job losses. However, in its second and third quarter, Reborn Cabinets gained additional partnership opportunities with companies such as with The Home Depot, Sam's Club and Costco, which resulted in a rapid surge in business. Reborn Cabinets was able to bring back all furloughed employees, and restart its recruitment efforts to keep up with growing demand.

In its Anaheim location, Reborn Cabinets manufacturers cabinetry that is shipped across California and the United States. This location includes Reborn University, a training center where professional development courses and hands-on training is administered. Reborn Cabinets is determined to keep their workers employed, while building the workforce needed to meet production goals.

Employment Training Panel training funds will allow Reborn Cabinets to train new and existing trainees on production manufacturing processes that will maximize efficiency. Employees will learn proper use and techniques of equipment for all activities, including planning, demolition, troubleshooting, customer interaction, and sanitation measures with appropriate cleaning supplies. Training under this project will ensure workers have the technical skills to manage multiple priorities while providing quality installation solutions.
