Employment Training Panel awards \$1.7 Million to Support Training State-Certified Electricians to Install Electric Vehicle Charging Equipment Statewide

**SACRAMENTO, CA –** On July 18, 2025, the California Employment Training Panel (ETP) in partnership with the California Energy Commission (CEC) approved \$1.7 million in funding to support 14 Electric Vehicle Training Program (EVITP) Fund programs. The goal of the awards is to support California's transition to zero-emission vehicles by ensuring state-certified electricians can install electric vehicle charging infrastructure. The organizations funded today will function as intermediaries between ETP and state-certified electricians as they obtain their EVITP certifications. Training is provided at no cost to the individuals.

California's clean energy future depends on a workforce that's ready to power it. This investment will help ensure workers have the skills to install and maintain our electric vehicle charging infrastructure while advancing the state's climate goals and opening doors to stable careers.

#### Why it Matters:

EVITP Fund grantees also focus on supporting areas of the state that do not currently have enough trained state-certified electricians to install and maintain charging stations. Programs will increase the economic and geographic diversity of EVITP state-certified electricians by ensuring that a minimum of 50 percent of funds are invested in employers or individuals located in disadvantaged communities, low-income communities, or rural areas. Trainees must receive EVITP certification in order to be supported by the program. EVITP offers a \$275 online course (approximately 20 hours) covering topics like load requirements, electrical codes, and charger installation. Certification is valid for 3 years.

The funding awarded today will help the state reach its goals of getting 5 million zero-emission vehicles onto California roads by 2030 and 100% of all in-state sales of passenger cars and trucks are to be zero-emission by 2035.

#### **Partnering to Support the ZEV Future:**

The Employment Training Panel (ETP) provides funding to employers to assist in upgrading the skills of their workforce through training that leads to good-paying, long-term jobs. Funded by California employers through a special payroll tax, the ETP operates as a funding agency— not a training provider. Businesses determine their own training needs and identify how best to deliver that training. The ETP has a tripartite governing structure, with appointed Panel members from business, unions, and state government. Since 2012, the ETP has partnered with the California Energy Commission (CEC) to support the Zero Emission Vehicle industry, including training for automobile manufacturers, bus mechanics, and electricians to service charging stations.

Zero-emission vehicles play an important role in California's efforts to reach its ambitious climate

and air quality goals. The CEC is the lead state agency investing in infrastructure to charge electric vehicles, which are available in plug-in hybrid electric and battery electric configurations. Through the Clean Transportation Program, the CEC also invests in training initiatives that are helping to drive the transition to clean, zero emission electric vehicles throughout the state.
