This list contains unemployment information for the most recent three-month period. To be considered a High Unemployment Area (HUA), a county, city, or CDP must have an unemployment rate **greater than, or equal to**, the ETP Threshold.

Definitions:

The **ETP Threshold** is based on the Statewide Average for each month:

- When the Statewide Average is **greater than, or equal to**, 10%, the ETP Threshold is calculated at 15% higher than the Statewide Average;
- When the Statewide Average is **less than** 10%, the ETP Threshold is calculated at 25% higher than the Statewide Average.

Full HUAs are counties with a county unemployment rate **greater than, or equal to**, the ETP Threshold. Every city and CDP within these counties is considered a HUA, regardless of the individual city or CDP unemployment rate.

Partial HUAs are counties with a county unemployment rate **less than** the ETP Threshold, but which do contain at least one city or CDP with unemployment rates **greater than, or equal to**, the ETP Threshold. Within these counties, only the specified cities and CDPs are considered HUA.

A **CDP** is a Census Designated Place
