ETP Approves More Than \$10.7 Million to Support Job Training Including \$747,676 for Large Boeing Expansion in Southern California

SACRAMENTO – The State of California's Employment Training Panel approved 61 contracts worth over \$10.7 million in job training funds at its public meeting yesterday. Both single and multiple employer contracts from various industry sectors throughout the state were presented for Panel approval. All approved funding will assist employers in strengthening their competitive edge by partially offsetting the costs of job-skills training to new and incumbent workers.

Boeing was approved for \$747,676 in Employment Training Funds to train a total of 347 new and incumbent workers at its Long Beach and Seal Beach locations – both part of Boeing's Southern California Design Center (SoCal). Proposed training will provide engineers with the tools, processes, and software to perform their jobs with the relative independence needed to sufficiently support the work at SoCal, and will allow Boeing to streamline processes and develop common practices. All training will be delivered by in-house subject matter experts.

Boeing's proposal has been designated a critical proposal by the Governor's Office of Business and Economic Development (GO-Biz). According to Tom Croslin, vice president, Southern California Engineering Design Center, Boeing Commercial Airplanes, "We are pleased to partner with California and continue this important relationship. We have a wealth of engineering talent in Southern California and one of the greatest concentrations of engineers in the country."

The Boeing Company (Boeing) is a manufacturer of commercial jetliners and military aircraft. Boeing also designs and manufactures defense systems, satellites, and launch vehicles. Boeing customers include most domestic and international airline carriers, NASA, and all branches of the military. Boeing anticipates strong growth in commercial aviation over the next several years and is scaling up its internal capability and capacity to meet the expected rise in demand for commercial airplanes and related service.

The Employment Training Panel is the state's premier program supporting job creation and retention through training. Since its inception in 1983, the ETP program has provided approximately \$1.25 billion to train more than 800,000 workers for more than 78,000 California companies.
